Summer Camp Facilitator Essential Job Functions Include:

 - Content areas can include: art, STEM, cooking, movement, outdoor adventures, financial literacy, social emotional learning, girls and women in history, etc.
- Ensuring girls safety, both physically and emotionally, though active supervision while they participate in structured program activities, offsite field trips, lunch and snack time and informal program time
- Abide and adhere to the safety requirements and procedures of our operations
- Keeping accurate records of attendance
- Evaluating programs for effectiveness of intended outcomes
- Being a mentor and leader setting a positive example and role model for the girls
- Participating in staff trainings, meetings, and events
- Maintaining organization and cleanliness of programming areas, resources, and supplies
- Creating a pro-girl environment
- Interacting with families in a positive and welcoming way

Minimum Requirements:

- 1 full year of work experience working with youth in a structured educational setting
- 12 college level units in early childhood education or any of the following comparable areas: sociology, psychology, art, music, dance, drama, recreation
- Ability to pass criminal background check or Clean criminal record
- Ability to pass a pre-employment physical and drug screening
- Vaccinations as required by State Law for licensed child care facilities (TB, Pertussis and Measles immunization. Flu vaccine recommended, but optional).
- Proof of COVID-19 vaccines and boosters. Exemptions may be requested for medical reasons or religious beliefs
- Strong communication skills and ability and desire to work as a team member of a diverse and dynamic team
